
POLICY RESOLUTIONS

The Iowa Institute for Cooperatives Legislative Committee met in early November to go over the Policy Resolutions for the next year. The committee reviewed the current resolutions and the proposed new resolutions. These resolutions were adopted at the 2021 Annual Meeting in November and will be the guidance

LEGISLATIVE REDISTRICTING

After a census is conducted every ten years, state legislatures across the country go through legislative reapportionment and redistricting. Iowa has frequently been credited with having the gold standard for redistricting and even with delays because of COVID, that standard will continue. After rejecting the first set of proposed maps, the state legislature approved the second set of maps that will become the congressional, state senate, and state house



districts for the next ten years. These new maps will become effective starting with the 2022 general election. The state legislature still has one more general session before these new maps take effect.

POSSIBLE ISSUES TO ARISE NEXT SESSION

While we don't have a crystal ball to presume the legislative future, we can make some general predictions about issues that may arise. Iowa closed out the last fiscal year with a budget surplus. Extra money in the state budget will probably mean some form of tax policy changes. Other issues we are expecting this upcoming legislative session include the bio-fuel standard bill that was a hot issue last session, and central filing which IIC will continue to fight.

Once session starts up in January, be on the lookout for a weekly legislative update on issues happening at the Iowa Capitol. In addition to these general updates, IIC will occasionally ask for your help with different issues. Whether that means collecting information on how potential legislation would affect your cooperative, or asking you to contact legislators to tell them about the impact of legislation, grassroots advocacy is one of the best ways to make cooperative voices heard at the Capitol.




IIC Welcomes Two New Board Members

Collaboration for Co-op Month

October is "Co-op Month" throughout the nation and was once again supported in Iowa with a state proclamation from Governor Kim Reynolds. This year, the Iowa Institute for Cooperatives teamed up with the Iowa Association of Electric Cooperative (IAEC) and the Iowa Credit Union League (ICUL) to launch a co-op month campaign with the goal of increasing Iowans' awareness of the valuable role various cooperatives play in their state.

The three organizations submitted a news release and an op-ed to media outlets across the state promoting October's Co-op Month. Social media was utilized throughout the month by not only IIC, ICUL, and IAEC, but social media packages were also disseminated to each group's respective co-op members to share through their communication channels as well. The central tool for October's Co-op Month campaign was a landing page hosted at IowaCooperatives.com. All social media advertisements and digital advertisements brought interested users to this page to learn about the benefits of the cooperative system. The digital advertising portion of this campaign earned over 1.5 million impressions, reaching primarily 20 to 44-year-olds in urban areas of our state.

It was a priority of the campaign to target young adults who will become the new membership-base of Iowa cooperatives in years to come. Thus, the campaign demonstrated the positive impact of cooperatives to that age demographic. We appreciated the opportunity to collaborate with our fellow membership organizations on this inaugural Co-op Month campaign.
