### Building Connections Broadband Grant Spells Big Opportunities for Rural Iowans

Throughout the United States, rural communities struggle with a lack of high-speed internet infrastructure, connectivity and opportunities.

Iowans have been working hard to lay the foundation for communicating how important broadband access is to our state. Nearly 500 of Iowa's 947 communities have fiberoptic broadband service. Roughly 400 of those communities connect fiber to every rural and urban person and business.


Hollee McCormick, General Manager of Allamakee-Clayton Electric Cooperative (ACEC) said, "Recently, the need for improved rural (and urban in many instances) internet is front and center. Federal and State grant opportunities are becoming more readily available, and we have been paying close attention and responding."

She also shared, "Allamakee-Clayton was awarded a grant from the State of Iowa to deploy roughly 200 miles of fiber to portions of northern Allamakee County. Our goal is to go where connectivity is needed while being a good neighbor to other telecommunications businesses and making economically sensible decisions. With those ideas in mind, we intend to keep moving forward and seek opportunities to improve our area's connectivity."

Steps are being made in Iowa policy to connect rural communities and farms to reliable broadband. The state has funded a broadband grant program since 2018—spending nearly \$170 million over four years (includes funds from the federal CARES Act). Governor Kim Reynolds recently signed HF 848 — the latest update on the Broadband Grant Program. The legislature also sent an appropriation for those broadband grants and maintenance costs worth \$100 million which will provide a tiered approach to grant funding based on current broadband access and capabilities.

"Wiatel recognizes the critical role reliable and affordable broadband plays in the lives of its customers," said Heath Mallory, CEO of Wiatel, Lawton. "Because of this, we have always been active in both legislative and regulatory lobbying efforts at the state and federal level. The importance of ensuring administrative rules, codes, and tax policies to encourage the deployment of broadband cannot be overstated."

He continues, "We work closely with both the Iowa Institute for Cooperatives and other telecommunication organizations to collaborate with state and federal governmental partners

"FMCTC is proud to have extended our fiber broadband out to customers that were not able to get 100/20 megabytes previously. This broadband grant funding allowed FMCTC to extend service to these locations and keep our rates equal to all subscribers of our Fiber Fast Broadband. We are glad that the State of Iowa has invested in the future."

The State of Iowa is making progress on this issue. However, time, money, and building materials still create barriers to connecting rural Iowans. A recent report by the U.S. Department of Agriculture estimated that bringing high-speed internet to unreached parts of the country would cost \$130-\$150 billion over the next five to seven years. A study done by the U.S. Chamber of Commerce's Technology Engagement Center additionally found "better adoption of online tools and digital services by businesses outside metropolitan areas could create 360,000 new full-time jobs in rural areas and add more than \$140 billion to the U.S. economy over the next three years."

We applaud our members that have and continue to connect Iowans across the state. Thank you for what you do to provide more opportunities for those who call our state home.

Dr. Harmon's appointment to the IIC Board further strengthens the partnership with ISU and provides another valuable perspective.


## Find Your Next Great Hire Using the IIC Job Board

Nominees are selected based on their significant contributions to cooperatives. Individuals nominated:


- Have demonstrated commitment to cooperatives and to the principle of cooperation

## A Recap of the 2021 Legislative Session

As covered on Page 1, we saw an updated broadband grant program with a tailored approach that focused efforts on deployment to Tier 1, or Iowans with speed services of less than 25/3 with various grant matches available based on level of service provided. In 2021, Iowa will also invest another \$100 million in broadband grants and Office of Chief Information Officer program maintenance plus \$50 million from CARES Act funds.

IIC also supported a bill creating an annual overweight permit for milk haulers to haul up to 96,000 lbs. on interstates (with the appropriate axles) and assisted on legislation that prohibits cities and counties from limiting propane service or sales.

Legislation was also passed this year that would provide childcare cliff relief helping people receiving state assistance by gradually reducing their assistance as they receive promotions and/or higher wages.

We saw a few things stall this year including a vegetation management bill that would have allowed RECs the opportunity to trim trees within specific boundaries to maintain reliable service. There was also a renewed attempt to correct a sales tax issue for RECs that was introduced but did not make it across the finish line in 2021.



Next year, we can expect to see central filing come back and will continue connecting with legislators about what the actual impact will be if Iowa moves to central filing from direct notice. We anticipate seeing a familiar bill on renewable fuels and 2022 would be a new opportunity to make progress on the Invest in Iowa Act (formerly IWILL), as most Iowans support increased water quality and conservation efforts.

On the federal side of things, we are continuing discussions on 199A and the implications to Iowa if that increased tax burden becomes a fixture from the reinterpreted 2020 U.S. Treasury rules. We're also engaging on the renewable fuels infrastructure bill introduced by Representative Cindy Axne (IA-03), and the impact on agriculture of changing a local highway to an interstate that would move large equipment onto other nearby, congested roadways.

A huge thank you to each of our members who talked with legislators and connected with them on co-op issues. Thank you to leaders that were able to assemble board of directors to meet last minute and those that individually attended virtual subcommittee meetings—thank you for showing up. Your voices made the difference in connecting legislators with the impact to agriculture and specifically, our farmer-members.
