## Live From The Hill

It has been a busy couple of months since the 2022 Session of the Iowa Legislative Events began on January 10. The current session started off with various leaders from the two chambers discussing priorities and moved into introducing bills and passing laws. During the last session, there was an additional surplus presented to the state reserves, which has tax reforms at

the top of everyone's minds at the statehouse. While I expect childcare and education to be hot topics during the spring session, I'll be following these other listed issues closely for IIC's member cooperatives.

#### **BIOFUELS ACCESS STANDARD**

In the annual Condition of the State address, Governor Kim Reynolds laid out her plans for the coming session including a proposal for a biofuel access standard. This proposal is different than the contentious one discussed last legislative session. HF 2128 would make retailers with E-15 compatible infrastructure sell E-15 on at least one gas pump by 2026. There are two exemptions in this bill. A class 1 waiver would be granted to retailers with tanks installed underground before 1985, double-wall fiberglass tanks installed before 1991, and single-wall fiberglass tanks installed before 1996. The second exemption in HF 2128 is based on the cost to upgrade equipment. If the cost to upgrade the retail site is more than what the site could secure in Renewable Fuel Infrastructure Program (RFIP) grants, a class 2 waiver will be granted. The Senate has currently passed the bill out of Agriculture Committee.

#### **TAX POLICY**

While Governor Reynolds proposed reducing Iowa's income tax to 4% flat tax over the next five years, Iowa legislators took it a step further reducing it to 3.9% flat personal income tax

by 2026. The bill also includes lowering corporate tax rates to an eventual 5.5%. Additionally, the plan exempts retirement income, including cash rent payments made to retired farmers. The bill passed both the Senate and the House, and the Governor has signed it.

The bill does not include the Senate's proposal of a change to Iowa's sales tax. Under the proposed Senate plan, the local option sales tax penny most places in the state use would become a statewide sales tax. It would have essentially changed the sales tax in Iowa from a 6% statewide plus 1% local to a 7% statewide sales tax. The increase in sales tax would have triggered funding for the Natural Resources and Outdoor Recreation Trust Fund that passed over a decade ago, but remains unfunded because it was tied to a sales tax increase. The first 3/8 of a sales tax increase goes into this fund to help pay for voluntary water quality initiatives, soil conservation, and other natural resources.

#### OTHER LEGISLATION WE'RE WATCHING

We have been, and will continue to, track legislation important to our members. The proposed HSB 655 would allow vehicles transporting corn, soybeans, hay, straw, silage, stover, or manure to haul up to 90,000 pounds on state and county roads, not interstates, so long as they abide by posted weight restrictions on bridges and highways. This bill would create a year-round exemption that mirrors the harvest proclamation the governor signs every fall. HF 2329 would allow financial institutions to use prize linked saving accounts to encourage people to save money.


"Succession begins long before the needs arise." This quote resonates from the second video in the series, Cooperative

## A New Path
